**MOTION FOR EXTENSION OF TIME  
TO FILE REPLY COMMENTS**

The American Cable Association (“ACA”) files this Motion seeking a one-week extension of time for parties to file reply comments in the above-referenced proceedings.

On June 13, 2014, the Commission released a Notice of Proposed Rulemaking and Further Notice of Proposed Rulemaking seeking comment on the Commission’s proposed regulatory fees for fiscal year 2014 and its efforts to improve the regulatory fee process.<sup>1</sup> The Commission established July 14, 2014 as the deadline for filing reply comments.<sup>2</sup> For the reasons described below, ACA seeks a one-week extension for parties to file reply comments.

ACA requests this extension to ensure that it and other interested parties can more fully develop the record in response to other comments filed in this proceeding. Numerous parties filed comments related to the Commission’s proposals, including the two direct broadcast satellite (“DBS”) commenters who jointly filed lengthy comments, including 3 appendices.<sup>3</sup>

Those comments in particular contain significant points to which ACA and others will be responding. Moreover, ACA and its counsel are small organizations with limited resources that are currently devoted to several other pending proceedings.<sup>4</sup>

The requested extension will provide the time necessary for interested parties to respond to significant points raised in other comments and will allow the Commission to develop a more complete record on the equitable allocation of regulatory fees to the DBS providers. Moreover, the requested one-week extension would not harm or prejudice the Commission or any interested parties, since it is unlikely to delay the proceeding in any meaningful way.

Although the Commission has not yet released Public Notices establishing the pleading cycles in either proceeding, ACA has been diligently evaluating the lengthy Public Interest Statements associated with each set of applications and initiating its analysis.

For the foregoing reasons, ACA requests a one-week extension of time for all parties to file reply comments in this proceeding.
